## **Request:**

## Police Pension Schemes and III Health Retirement Benefits

- 1. Since 2008 please advise the number of officers who have been admitted to the PSNI and to a Police Pension Scheme.
- 2. Of those admitted to a Police Pension Scheme please advise the number who were excluded from that schemes III Health Retirement Benefits.
- 3. Please confirm the number of PSNI Officers who after being initially excluded from III Health Retirement Benefits Package appealed this decision or subsequently re-applied for entry into the III Health Retirement Benefit Package.
- 4. Of those referred to above at 3 please confirm the number who were successful.
- 5. Please advise the process by which a member of the Pension Scheme who originally excluded from the III Health Retirement Benefits can re-apply for consideration to III Health Retirement Benefits.
- 6. In relation to any application process to apply for consideration for III Health Retirement Benefits please provide a copy of all Guidance issued in relation to same.
