## Request:

I seek information from NIPB as under in accordance with FOI procedure.

1. Confirm NIPB Poilcy/procedure regarding retention of SMP Clinical notes

**Answer -** All papers processed by the Northern Ireland Policing Board (the Board) to include the contemporaneous written notes made by the Selected Medical Practitioner (SMP) during assessments are held in line with the Board's Retention and Disposal Schedule.

2. Since the introduction of new in house arrangements in 2016 confirm it has been established practice for NIPB to take possession of all SMP Contemporaneous Clinical notes, recorded during IOD, IHR interviews without consent form those subject of assessment/examination. To what extent has this been an ongoing practice.

**Answer -** The Board collects and processes information, to include the SMP's contemporaneous written notes, in order to meet its public function and to perform various statutory duties conferred on it by Injury on Duty and III Health Retirement legislation. The lawful basis for processing this information is therefore not consent but rather "public task" further to Article 6(1)(e) UKGDRP.

3. Confirm the practice as per Q3 is not in accordance with current Data Legislation.

**Answer -** Further to the response to Question 2 (above), no such consent is required.
