Request:

PASS (NI) is concerned re the possible breech of Data Legislation regarding the USE/RETENTION of SMP contemporaneous notes.

Could you provide a response to the following FOI request?

- 1. To what extent does NIPB retain SMP Clinical Contemporaneous notes, following IOD/III Health retirement assessments at Waterside Tower?
- 2. Under GDPR what authority has NIPB to take possession of such notes and retain for indefinite periods?
- 3. Is it NIPB practice/policy to retain such notes without proper authority and written consent from the individuals who are the subject of the assessments?
- 4. What consultation, if any, has NIPB had with SMP's to hand over such notes, without consent?
- 5. How long has this unlawful practice been operating?
- 6. How many complaints has NIPB received over the past two years as a result of this unlawful practice?
- 7. Please quantify the number of Data Protection breeches [sic] over the past two years as a result of this unlawful practice?
- 8. What action does NIPB intend to take, to cease this unlawful practice, including advice to SMP's?
- 9. Resulting from this FOI request, please confirm how and when NIPB will return all contemporaneous clinical notes held back to SMP's?
- 10. Confirm also that all Officers/Retired Officers, affected by this practice, shall be individually advised of their notes having been unlawfully held by NIPB/handed over to SMP's.
- 11. Please confirm that NIPB, shall, upon response to this FOI request, publish this request and response on NIPB website under Publications?

Answer:

- 1. All papers processed by the Northern Ireland Policing Board (the Board) to include the contemporaneous written notes made by the Selected Medical Practitioner (SMP) during assessments are held in line with the Board's Retention and Disposal Schedule.
- 2. The Board collects and processes information, to include the SMP's contemporaneous written notes, in order to meet its public function and to perform various statutory duties conferred on it by Injury on Duty and III Health Retirement legislation. The lawful basis for processing this information is "public task" further to Article 6(1)(e) UKGDRP.
