Introduction



This report assesses the quality of the Community Policing Survey management statistics for the Northern Ireland Policing Board using the European Statistics System (ESS) Quality Assurance Framework (QAF). This is the method recommended by the Government Statistical Service (GSS) Quality Strategy. Statistics are of good quality when they are fit for their intended use.

The ESS QAF measures the quality of statistical outputs against the dimensions of


- ✓ relevance
- ✓ accuracy and reliability
- ✓ timeliness
- ✓ accessibility and clarity
- ✓ comparability and coherence

The GSS also recommends assessment against 3 other principles in the ESS QAF. These are:

- ✓ trade-offs between output quality components
- ✓ confidentiality and transparency
- \checkmark balance between performance, cost and respondent burden

These dimensions and principles cross the three pillars of trustworthiness, quality and value in the Code of Practice for Statistics. <u>Code of Practice for Statistics</u> (statisticsauthority.gov.uk)

Background and Context



This quality assessment covers the Community Policing Survey statistical report which provides information about the public perception of community policing in Northern Ireland and views on community involvement in reaching mutually satisfactory solutions to local problems.

The first survey of this nature and took place between 3 April 2023 and 30 June 2023. The results of this survey were published in December 2023. This background quality assessment, considers the quality of the data used to produce this publication, and any statistics derived from these data.

Methodology and Production

The purpose of the survey is to monitor Outcome 3 within the Policing Plan which is about building the relationship between police and the community. The Policing Board undertook this research on the experience of individuals in their community, working with the Police Service of Northern Ireland to assist in informing the Policing Plan, with specific regard to delivery of measure 3.1.3 (assess and evaluate the impact of partnership working with local communities).


The survey also added to the information gathered between January and March 2023 by the Board's Policing Plan Survey: <u>Policing Plan Survey</u>

The Community Policing Survey itself was short, consisting of 8 questions. The balance between performance and respondent burden was considered and factored into the development of the survey. The 2023 survey was viewed as a pilot survey to provide some timely and relevant information for the Board to consider in assessing police performance against agreed outcomes.

Community involvement in this area is diverse, informal and often unrecorded. However, from the outset, the intention of this survey has been to capture general views of a sample of individuals, neighbourhood groups and other organisations who are involved with PSNI in tackling community policing issues. It is intended to be used as management information for the Board and is not published as official statistics.

The nature of this survey therefore, which does not take views from a representative sample of the population and could therefore have the potential for bias, cannot be used to draw conclusions about the population generally. It is merely, intended to give some indication of general views on community policing and to provide some context for the Board's assessment of Outcome 3 of the <u>Policing Plan 2020-25 and Performance Plan</u> 2022/23.
