Request:

Please can I request a copy of the guidance from the Policing Board issued to SMP and IMR as mentioned within the draft Statutory Rules: The Police Service of Northern Ireland and Police Service of Northern Ireland Reserve (Injury Benefit) (Amendment) Regulations 2023.

These regulations make amendments the Police Service of Northern Ireland and Police Service of Northern Ireland (Injury Benefit) Regulations 2006 and <u>make provision to place the guidance provided by the Board to Selected Medical Practitioner (SMP) and Independent Medical Reviewer (IMR) to carry our Injury on duty assessments on a statutory footing.</u>

Answer:

I can confirm that the Northern Ireland Policing Board (the **Board**) holds the information you requested. However we are withholding that information since the exemption under section 22 of the FOIA (Information intended for future publication) applies to it.

The document requested is a joint document between the Board and the Department of Justice (**DoJ**). A consultation has recently closed in relation to the guidance document, therefore with that in mind as it is still in draft format it cannot be released until it is final. The final version of the document requires passing through the Assembly to obtain statutory footing, therefore at this stage it may be subject to further amendments. Following passing through the Assembly, the information will be available on the Board's website at the following link:

The section 22 exemption is a qualified exemption and is subject to consideration of a public interest test. This means that a public authority must determine whether, on balance, it considers it to be in the wider public interest to maintain the exemption, or to release the requested information. We have carried out a public interest test, (attached) and we are satisfied that in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.

Exemption at Section 22 of the FOIA – Information Intended for Future Publication

PUBLIC INTEREST TEST CONSIDERATIONS

Requested information – A copy of the guidance from the Policing Board issued to SMP and IMR as mentioned within the draft Statutory Rules: *The Police Service of Northern Ireland and Police Service of Northern Ireland Reserve (Injury Benefit) (Amendment) Regulations 2023.*

Arguments that weigh in favour of disclosure

Release of the information would promote transparency, accountability and participation.

Providing the requested information is in line with the spirit of openness and transparency enshrined within FOI legislation.

Arguments that weigh in favour of maintenance of the exemption

This document is a draft document shared between the Department of Justice and the Northern Ireland Policing Board. The finalised version of this guidance document is not yet available.

A consultation exercise has only recently closed on this guidance document. With that in mind the next stage of the process will involve the document passing through the Assembly to enable it to be placed on a statutory footing. At this stage it may be subject to scrutiny requiring further amendments to be made.

The Board should not place information in the public domain that may be inaccurate and subject to future amendment.

Decision

In all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
