## Request:

Gas contract has expired. Please provide the latest contract updates.

- Please share the NHH, HH, Gas and Specialist Gas/Liquid meter points of Energy Management
- Please confirm when the Energy Management System will be implemented. It would be helpful if you mention the month/year.

## Answer:

On 27<sup>th</sup> March 2023, the Northern Ireland Policing Board moved from Waterside Tower (31 Clarendon Dock, Clarendon Road, Belfast, BT1 3BG) to a Department of Finance owned and managed premises at James House (2-4 Cromac Avenue, The Gasworks, Belfast, BT7 2JA). The Policing Board can, should it wish, avail independently of the CPD energy supply related collaborative contracts listed below:
