Request:

1. The full unredacted copy of the Schofield Review completed in November 2014. The version published 10 years ago still contains redactions

Answer:

We can confirm that the NI Policing Board does hold information falling within the terms of your request.

We have considered your request and consider that a number of exemptions apply to sections of information contained within the Scoffield Review.

The specific exemption(s) which apply in relation to your request are:

• Section 40 (2) Third Party Personal data.

References are made throughout the Review to third party personal data. This personal information is exempt from disclosure to you under section 40(2) by virtue of section 40(3)(a)(i) of the FOIA.

Section 40(2) allows a public authority to withhold information from a response to a request for information under the FOIA when the information requested is personal information relating to someone other than the requester and its disclosure would contravene one of the data protection principles.

The first data protection principle requires personal data to be processed fairly and lawfully. This personal data is exempt from disclosure under section 40(2) of the FOIA as, in our view, it would be unfair to provide it to you, and therefore disclosure would be in contravention of the first principle of the UK General Data Protection Regulation. This is an absolute exemption and there is no requirement to conduct a public interest test.

• Section 42 Legal Professional Privilege -

The redacted portions of Chapter 13 are considered to be exempt from release as the exemption at Section 42 (1) Legal Professional Privilege of the Freedom of Information Act 2000 is engaged. Specifically, the redacted information is considered to attract 'Advice Privilege'

Section 42 of the Act is a qualified exemption and as such has been subject to a 'Public Interest Test' a copy of which is attached at **Appendix A**.

In all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.

2. The amount of public money spent by the Northern Ireland Policing board relating to the Schofield review.

According to the Board's financial records the value spent in relation to the Scoffield review is $\pounds 43,410.00$

The amount of public money spent by the Director of Police pensions and injury benefits acting on behalf of the board spent during the "paper-based review of each of the cases" by the "two doctors who had no previous involvement in any of the eight cases" in relation to the Harveson and Chadwick Judicial review. Answer:

Correction made 13 February 2025 - Due to an administrative error the Northern Ireland Policing Board wishes to correct its answer to this question

Our original answer stated that the cost of paper-based reviews of eight cases completed by two Selected Medical Practitioner's (**SMPs**) amounted to £11,200. This should in fact be £5,940 for the completion of a total of nine reviews completed by two SMPs.
