Answer:

Question 1. Since August 2020, the amount paid to medical professionals is £700.

Question 2. The total cost paid is £700.

Question 4. This is deemed to be the personal data of a third party. It is exempt from disclosure to you under section 40(2) by virtue of section 40(3)(a)(i) of the FOIA. Section 40(2) allows a public authority to withhold information from a response to a request for information under the FOIA when the information requested is personal information relating to someone other than the requester and its disclosure would contravene one of the data protection principles. The first data protection principle requires personal data to be processed fairly and lawfully. This personal data is exempt from disclosure under section 40(2) of the FOIA as, in our view, it would be unfair to provide it to you, and therefore disclosure would be in contravention of the first principle of the UK General Data Protection Regulation (UKGDPR). This is an absolute exemption and there is no requirement to conduct a public interest test.
