Request.

1. How many serving police officers were referred to the Board for ill health medical retirement in the last two years? (IE..were eligible and approved)

That would be 2023 and 2024.

- 3. How does this compare to the previous two full years 2022 and 2021?
- 4. Please list 5 main reasons for medical retirement?
- 5. How many police officers are currently waiting approval for ill health medical retirement?
- 6. Please list 5 main reasons for medical retirement?

Answer:

I can confirm that the Board holds information falling within the description specified in your request under questions 1, 2, 3, 4 5 & 6. However, we estimate that the cost of complying with this request would exceed the appropriate limit. The appropriate limit has been specified in regulations and for the Board it is set at £450. This represents the estimated cost of one person spending 18 hours in determining whether the Board holds the information, retrieving and extracting the information. Under section 12 of the Freedom of Information Act the Board is not obliged to comply with your request under questions 1, 2, 3, 4 5 & 6 so will not be processing your request further.

Guidance published by the Information Commissioner's Office (**ICO**) states that where a public authority claims that section 12 of the FOIA is engaged, as in this case, the public authority should, where reasonable, provide advice and assistance to help the requestor refine their request so that it can be dealt with under the appropriate limit.

If you narrow the scope of your request to one year, for example, 2023 - 2024, the Board may be able to provide the information required because it would cost less than the appropriate limit to do so. If questions 2 & 4 are dropped, then the Board can provide a response to all years requested. In addition, please advise if your wish for the yearly figures to be calculated in calendar

or financial year? Finally, the Board cannot provide a response to question 6 until the officers go through medical assessment.

Any reformulated request the Board receives from you will be treated as a fresh FOI request.
