Purpose and lawful basis for processing

Our purpose for collecting this information is so we can facilitate your attendance at a Policing Board meeting in public or at another Board event and provide you with an acceptable service.

The lawful basis we rely on for processing your personal data is your consent under article 6(1)(a) of the UK GDPR.

When we collect any information about dietary or access requirements we also need your consent (under article 9(2)(a)) as this type of information is classed as special category data.

What we need

If you wish to attend the Board's meeting in public or one of our events, you will be asked to contact the Board via email to register attendance.

If attending a Policing Board event we may ask for details of your organisation's name and information about any dietary requirements or special access provisions you may need.

Why we need it

We use this information to facilitate attendance at the meeting in public and provide you with an acceptable service. We also need this information so we can respond to you.

What we do with it

The personal data collected will not routinely be shared outside of the Northern Ireland Policing Board (NIPB).

Please note, however, that we may be required to share your data to meet our legal or public function requirements, to pursue debt, for fraud, or crime prevention and detection purposes, or in your vital interest.

We may receive Freedom of Information and Environmental Information Regulations requests for third party personal data. We have a legal obligation to process any personal data we hold when considering requests under these laws. In most cases we will consider whether disclosure would contravene principle (a) of the GDPR.

We don't publish delegate lists for events.

How long we keep it

We will delete personal information confirming attendance at Policing Board meetings in public or Policing Board events 1 month after the date of the event.

For further information about how long we hold personal data, see our retention and disposal schedule.

What are your rights?

We rely on your consent to process the personal data you give us to facilitate the event. This means you have the right to withdraw your consent at any time. If at any point you want to withdraw your consent please email:
