Request: Could I please have your staff number in total.

This should include all committee members and numbers within each sub department.

I also require your total staffing number split into the following groups (% & numbers)

The religious break down of the NIPB

The gender break down of the NIPB

The age break down of the NIPB (grouping in five years increments)

The number of staff with a disability.

The number of staff members working from home and number of days each week staff members work from home.

I would also like to know if NIPB telephone call are recorded.

Answer:

The Northern Ireland Policing Board currently has 45 permanent staff [This includes 1 official seconded out]; plus 2 seconded in staff; and 6 agency; and 19 Board Members.

The number of staff in each branch [this doesn't include Board Members] is broken down as follows:

- Senior Management Team 5
- Police Performance Monitoring Branch 4
- Police Human Rights & Professional Standards Branch 5 [doesn't include 1 seconded out]
- Partnership Branch 4
- Engagement Branch 3
- Communications Branch 5
- Police Pension & Injury Benefits Branch 11
- Finance Branch 5
- Strategic Planning & Governance Branch 4

- Emerging Priorities Branch 3
- People & Organisational Development Branch 3

We can only provide the religious breakdown of permanent staff [45 staff] as we don't hold this information for Board Members, Agency staff or secondees in:

- Protestant 19 staff (42%)
- Roman Catholic 21 staff (47%)
- Non Determined 5 staff (11%)

Gender breakdown for all NIPB staff groups and Board Members:

- Male 35 (49%)
- Female 37 (51%)

We can only provide the age breakdown of permanent staff [45 staff] as we don't hold this information for Board Members, Agency staff or secondees in:

- Up 30 = 3
- 31-35 = 3
- 36-40 = 7
- 41-45 = 7
- 46-50 = 7
- 51-55 = 10
- 56 60 + = 8

We can only provide the number of staff with a disability for permanent staff [45 staff] as we don't hold this information for Board Members, Agency staff or secondees in:

3 staff have declared as having a disability

Staff have the option to work on a hybrid basis and the number of days spent working from home is dependent on the business need.

NIPB do not record telephone calls.
