- 2. How many applicants received a change to their banding after a reconsideration?
- 3. The number of officers / retired officers who have applied for a reconsideration in relation to their reassessment date only, IOD/RIOD? How many applicants have been granted a reconsideration?
- 4. How many applicants received a change to their reassessment date after a reconsideration?
- 5. The number of officers / retired officers who have applied for a reconsideration in relation to their implementation date only, IOD/RIOD? How many applicants have been granted a reconsideration?
- 6. How many applicants received a change to their implementation date after a reconsideration?
- 7. The number of officers / retired officers who have applied for a reconsideration in relation to their banding and implementation date only, IOD/RIOD? How many applicants have been granted a reconsideration?
- 8. How many applicants received a change to their implementation date after a reconsideration?

Answer:

I can confirm that the Board holds information falling within the description specified in your request under questions 1, 2, 3, 4 5 6 7 & 8. However, we estimate that the cost of complying with this request would exceed the appropriate limit. The appropriate limit has been specified in

regulations and for the Board it is set at £450. This represents the estimated cost of one person spending 18 hours in determining whether the Board holds the information, retrieving and extracting the information. Under section 12 of the Freedom of Information Act the Board is not obliged to comply with your request under questions 1, 2, 3, 4 5 6 7 & 8 so will not be processing your request further.

Guidance published by the Information Commissioner's Office (**ICO**) states that where a public authority claims that section 12 of the FOIA is engaged, as in this case, the public authority should, where reasonable, provide advice and assistance to help the requestor refine their request so that it can be dealt with under the appropriate limit.

If you narrow the scope of your request to from January 2019 – December 2021, or from January 2021 – November 2022, or from November 2022 to 2025, the Board may be able to provide the information required because it would cost less than the appropriate limit to do so. The reason for this is that the data you requested is not accessible in electronic form from 2019 until November 2022 and requires a manual review of hard copy files.

Any reformulated request the Board receives from you will be treated as a fresh FOI request.

You should make complaints to the ICO within six weeks of receiving the outcome of an internal review.
