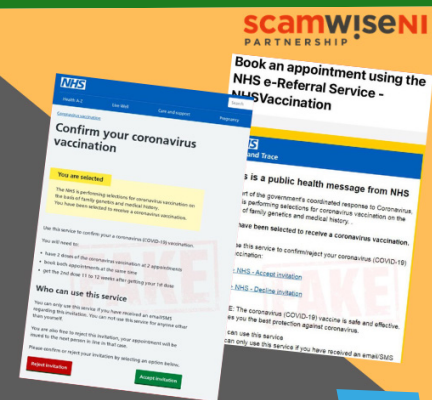

MAKING YOUR MARK!

TRAILER MARKING

Fermanagh & Omagh PCSP, working with local PSNI, have held a trailer marking event in Irvinestown.

Trailer marking involves stencilling a unique code on the trailer, making it easier for PSNI to trace stolen vehicles and equipment.

Trailers that have been marked also act as a deterrent to would-be thieves, letting them know they won't be able to hold on to their ill-gotten gains for long!

To make sure everyone stayed safe, residents were invited to book slots to ensure social distancing could be maintained where possible, and masks were worn throughout.

BIKE MARKING

With the theft of bicycles on the rise in Newry, Mourne & Down, the PCSP and PSNI decided to take action. Setting up next to the bike path in Kilbroney Forest Park, the PCSP staff and PSNI Officers offered free bike marking and free crime prevention advice.

When bikes are marked, their details are kept on a central database, and once applied the marking stickers can't be removed, showing thieves they've no chance of riding off into the sunset!

The day was a success, with a lot of positive feedback – Newry, Mourne & Down PCSP have already started planning even more events in more locations for 2021!

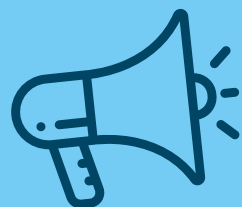
STAYING SAFE ON THE ROADS

Living and driving in a rural location brings a range of dangers on the roads, especially in Causeway, Coast & Glens which has the busy A26 running through the Council area. After a rise in the total number of fatal road traffic incidents, the PCSP decided to run a campaign to highlight the dangers on our roads both over the festive period and beyond.

Setting up a working group to ensure the messaging was as relevant as possible, the PCSP settled on an awareness campaign running across December and January focusing on drink & drug driving, speeding, using your mobile phone, and awareness around agricultural vehicles.

To make sure as many people as possible saw the messaging, Causeway, Coast & Glens PCSP launched across a number of platforms: bus rears, shopping centres, social media, and a local radio ad.

Councillor Oliver McMullan, Chairman of Causeway Coast and Glens Policing and Community Safety Partnership, said: "Causeway coast and glens residents and visitors need to know and understand the dangers on our roads. Taking the chance of driving while under the influence of alcohol and or drugs, speeding or using your mobile phone while driving are all against the law and could result in a serious accident to themselves or someone else, the PCSP asks the public to be smart and think safety first."

A NEW GENERATION OF LEADERS

Ards & North Down PCSP have been working with the Council's Sports Development team and local sporting organisations to deliver a series of innovative sports leadership programmes aimed at redirecting young people who have been engaging in anti-social behaviour.

Continuing to connect with communities is essential, so rather than wait, the PCSP have partnered with Sports Community Network to deliver the programmes through online sessions. The sports leadership programme is just one of five new initiatives that the Council and PCSP will be undertaking over 2021 to address issues of criminality in the Borough and help improve confidence in policing.

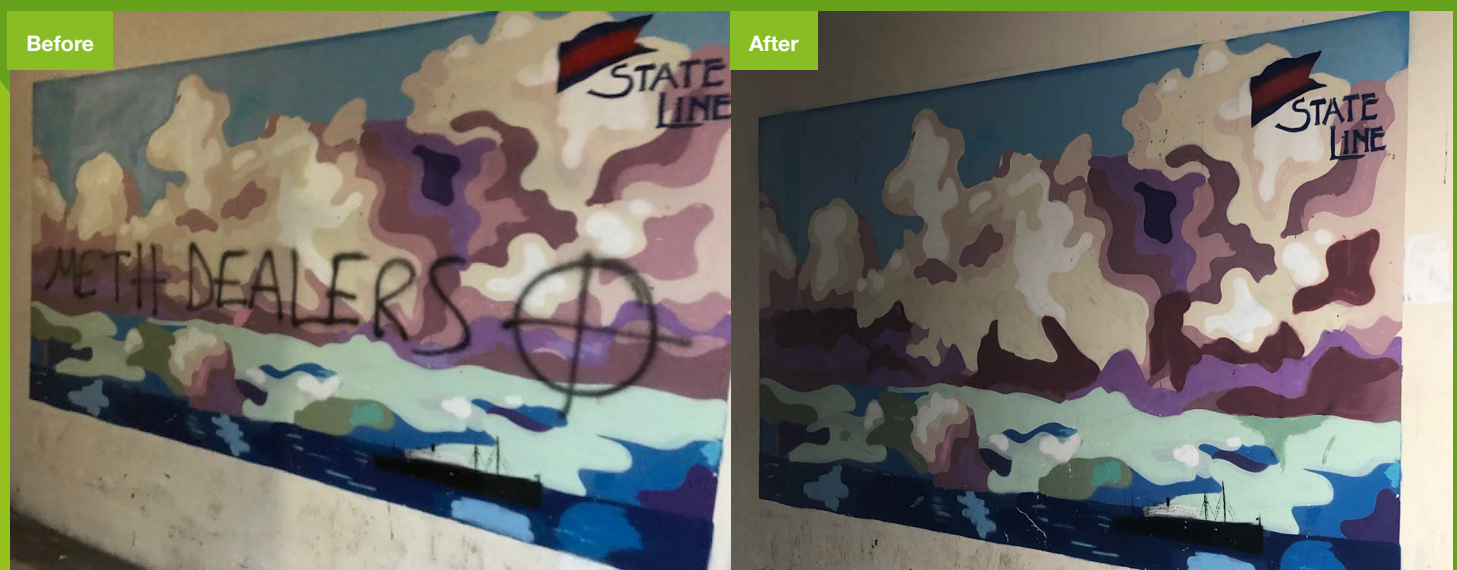

COMMUNITY SAFETY WARDENS CONTINUE!

Mid & East Antrim PCSP have ensured three more years of Community Safety Wardens, extending their project work with NIHE and Ballymena Retailers Against Crime (BRAC) to employ three Wardens stationed throughout the Council area.

The Community Safety Warden project has been running since 2012, and the Wardens have assisted on issues like anti-social behaviour, drug abuse, local safety problems, graffiti, litter and dog fouling. A recent survey also showed that Wardens have helped address fear of crime locally, and have been a reassuring presence in both the community and for local businesses.

Feedback on the Warden scheme has been exclusively positive, with Wardens often assisting vulnerable individuals, and creating on-the-ground solutions to problems like antisocial behaviour. Wardens can also provide necessary advice and guidance to anyone who needs it.

RAISING AWARENESS OF DOMESTIC VIOLENCE

Following a concerning rise in domestic and sexual violence across Newry, Mourne & Down during COVID-19 lockdowns, the PCSP took the decision to fund and organise virtual domestic violence awareness raising sessions in partnership with South Eastern Domestic and Sexual Violence Partnership (SEDSVP).

The goal of the project was to raise awareness about the many types of domestic violence, and the fact there is no one type of victim. Particular attention was given to domestic violence issues with male, LGBTQ+ and BAME victims. The sessions gave more information on spotting the signs of domestic violence, what could trigger incidents, support for victims and the services which are available to those who have been victims.

Newry, Mourne & Down PCSP wanted to reach as many different organisations as possible to spread awareness across the District, and attendees came from a wide variety of organisations across the statutory, voluntary and community sectors. Sessions were as inclusive as possible – for example one session focused on domestic abuse affecting men, and was run in conjunction with both Men’s Advisory Project and the Rainbow Project, giving an overview that included all genders and relationships.

Newry, Mourne & Down PCSP also worked directly with Women’s Aid to deliver aspects of the project related to BAME communities directly to interpreters, meaning their experience of domestic abuse could reach those who need it with no language barrier. 100% of those who attended stated that their knowledge and understanding of domestic abuse in BAME communities had improved.

NEW PENALTIES

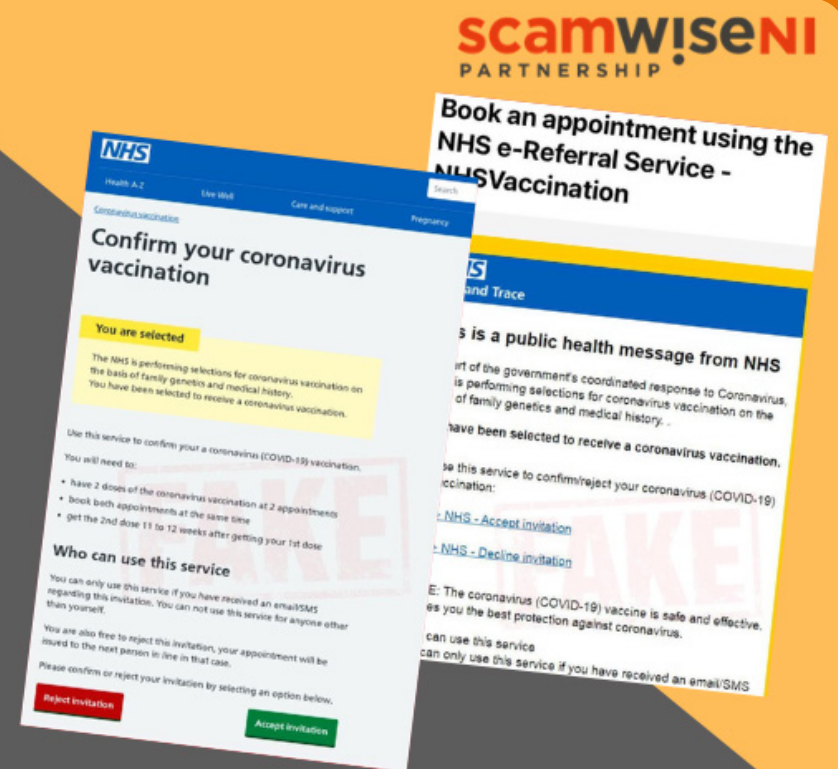

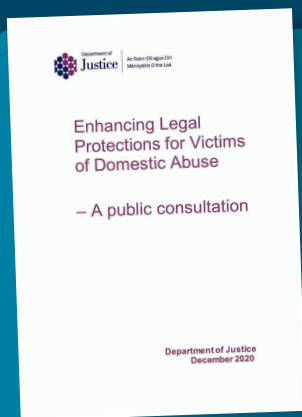
RECRUITING: INDEPENDENT COMMUNITY OBSERVERS
