Christmas this year might not be what we're used to. In fact, it will probably be very different indeed! However, there's still certain seasonal safety measures we should follow. Remember to check the <u>latest Covid-19 safety advice</u> and follow the guidelines so we can keep ourselves and others safe.



STAY SAFE SOCIALISING

Although we might not be donning our glad rags for the office party or going for a big festive meal out, we still need to remember to stay safe out and about. So if you're planning to indulge in a bit of Christmas cheer, follow our 'elf and safety' tips:

- Never, ever drink and drive or under the influence of drugs and stay within speed limits.
- Always plan your journey home but remember you may still be over the limit the morning after.
- Walk in bright, well-lit areas.
- Look after your valuables.

STAY SAFE AT HOME

You might not be leaving the house unattended that much this year but that doesn't mean you should get lax on home safety. Here's how to keep your grotto safe, and presents secure and ready for under the tree:

- Lock all doors and windows even if you're just going for a short walk.
- Keep presents hidden, in both the house and car.
- Lock your sleigh car doors.
- Mark all valuables with your postcode/house number and take photos of them as this may make it easier to track them if stolen.
- Turn off Christmas lights and consider other fire hazards such as candles.



SHOP SAFELY ONLINE

Many of us will be leaving the reindeer and sleigh at home this year and instead we'll be ordering sacks of presents online straight to our door (or down the chimney!) However if you're getting gifts for those on your 'Nice List', make sure the scammers end up with nothing but coal in their sacks by following these tips:

- Only buy from websites you know and trust.
- Check the website address bar has a lock symbol in the address barKeep your password safe and vary it between sites.
- Be careful about what links you click and where you're entering your password.
- If a deal seems too good to be true, it probably is!
- Lots of 'pop ups' promising great deals are really fake pages trying to take your bank account details.

HOME SAFETY PACKS HELP KEEP HOMES SAFER

Newry, Mourne & Down PCSP have been helping improve home safety and reduce fear of crime in their community by distributing home safety packs to vulnerable members of the community, older people living alone, previous victims of home burglary and people living in areas identified as high risk for burglaries.

Packs were distributed through local Councillors, PCSP members, Neighbourhood Watch Coordinators and Officers from the Neighbourhood Policing Team after being collected from Newry Leisure Centre, in accordance with Covid-19 guidelines.

The home safety packs contained:

- Personal attack alarm with torch
- Window entry alarm
- Door stop wedge alarm
- 24-hour segment light timer
- Permanent UV marker pen
- Contactless card blocker
- Information leaflets

VOLUNTEER SAFETY WARDEN SCHEME ESTABLISHED

Thanks to funding from Derry & Strabane PCSP, Melmount Community Forum has been able to purchase equipment to support the establishment of a new Volunteer Safety Warden Scheme within Strabane and associated areas. The scheme engages with the community and helps to deter those partaking in anti-social and high-risk behaviour and signpost them to available and relevant services.

In addition to radios, chargers and body worn videos, the PCSP's involvement also allowed invaluable engagement with PSNI Neighbourhood Officers, PCSP Community Safety Wardens and Foyle Search and Rescue, ensuring best practices and dissemination of shared experiences.

The Volunteer Safety Warden Scheme will carry out weekend patrols over a 12-month period in areas identified as high problem hotspots.



SAFETY TAKES TOP BILLING AT THE DRIVE-IN

It was a message much more important than the usual movie soundtrack that was blaring through the car radios at the drive-in in Loughbrickland recently. In a local church that's been set up for drive-ins, Armagh, Banbridge & Craigavon PCSP hosted a Scam and Crime Prevention Information Drive-In Event.

PCSP Project Officer Billy Stewart spoke to almost 70 older people, working from the boot of his car and tuned in to their car radios. The messaging for the talk centred on scams, home security and personal security.

The event was held in partnership with The 60+ Luncheon Club and replaced usual in-person talks. Feedback from the event was positive with reports of all enjoying and feeling much benefited by the information received.

PARK WATCH SCHEME LAUNCHED

In Lisburn and Castlereagh the parks should be feeling safer after the launch of a Park Watch scheme designed to combat vandalism and anti-social behaviour.

Lisburn & Castlereagh PCSP worked with local PSNI and the Council's Parks & Amenities and Environmental Health to create five Park Watch Schemes. The schemes involve the organisations working together along with local residents with the aim of protecting the parks and maintaining a safe and friendly environment for all.

The Park Watch Schemes currently cover Wallace Park, Lisburn, Duncan's Dam, Lisburn, Moira Demesne, McKee's Dam, Hillsborough and Cairnshill Playing Fields, Four Winds, Belfast.



PARKING CONES GET A MAKE-OVER IN THE NAME OF SAFETY

Fermanagh & Omagh PCSP recently delivered a number of new parking signs to schools in the Fermanagh and Omagh District Council area where problems with illegal and inconsiderate parking had been identified. Working in partnership with the PSNI and local schools the innovative signage reminds adults just who they're putting at risk by parking poorly and dangerously.

"Inconsiderate parking around schools is putting the safety of children and others at risk. Our advice to drivers stopping near schools is simple:

- · Never park outside or opposite school gates
- · Never park on yellow lines or zig-zags
- Do not park on footpaths
- · Do not obstruct residents driveways or dropped kerbs
- Do not obstruct the school crossing patrol
- · Never park within 15m of a junction"






NEW UNIFORM TRIAL




