If there is more than one supplier please split the annual averages spend for each supplier. **£84, 883 including VAT or £70,846 excluding VAT (NIPB does not pay vat) over the first 2 years of the contract (contract runs from Oct to Oct each year).**
 3. Number of Users: Please can you provide me with the number of users this contract covers. Approximate number of users will also be acceptable. **70**
 4. Contract Type: Managed, Maintenance. **Managed**
 5. Hardware Brand: What is the hardware brand of the LAN equipment? **Hewlett Packard (HP)**
 6. Contract Description: Please provide me with a brief description of the overall contract. **Replacement ICT Infrastructure with supporting services.**
 7. Contract Duration: What is the duration of the contract and can you please also include any extensions this may include **The initial contract is for**

3 years, from October 2011 - 2014 with the potential for two 1 year extensions.

8. Contract Expiry Date: When does the contract expire? **October 2014, October 2015 or October 2016 (dependant on whether the contract extensions are used).**

9. Contract Review Date: When will the organisation be planning to review the contract? **Initially in June 2014 and then June 2015 if the contract is extended in June 2014.**
